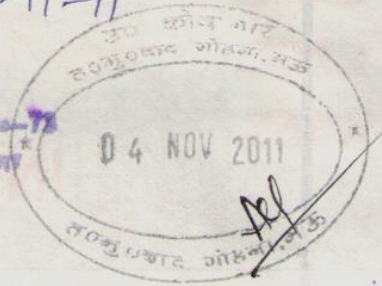

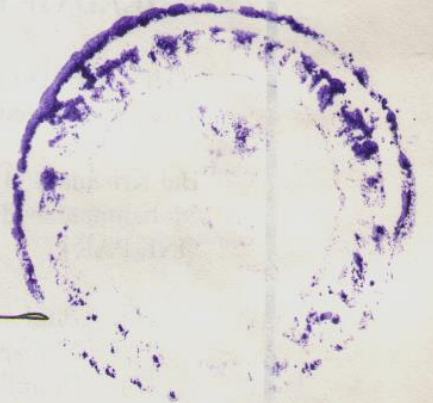

AND WHEREAS the Trustees have also accepted the Trust Fund as stated above.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS

1. The Trust shall hereby be called "NATURAL NAITIK NASTIK FOUNDATION". The office of the Trust shall be at Mohalla- Jamalpur, P.O.- Mohammadabad Gohna Distt.- Mau (U.P.), and at such other place or places as the trustees here in may decide from time to time.
2. The SETTLOR herein will be hereinafter called "FOUNDER TRUSTEE" and other Trustees of the Trust together will be called the "TRUSTEES". The minimum number of the Trustees shall be Three (3) and the maximum number shall be Nine (9).

18. The Board of Trustees shall meet often as may be necessary or convenient to transact business. The Board of Trustees might transact business and take decisions also by circulation papers.
19. All decisions of the Board of Trustees shall be taken either unanimously or by majority and if the board divided, the Master Trustee will have the casting vote.
20. Without prejudice the powers of the Board of Trustees the Master shall manage and administer the affairs of the trust and shall also exercise such power and function as may be delegated to him by the Boards of Trustees.
